Dear Don and Ann -

I hope this letter finds you both in great spirits and excellent health. From all my years growing up in Wisconsin (Lake Geneva) - I remember the Fall being beautiful with the turning of the tree leaves. I hope this is the same in your neighborhood.

Don - I must ask you a very Frank question on attitudes among the majority of the noteholder's. - Wind Plus, et al. - First, let me give you some background information to assist your thoughts.

Don and Ann - Please carefully read, consider and respond.

After I was challenged, I had only a few days in late May to develop a quick, effective business strategy. I'm proud of my positive results.
